## Overview

Qulliq Energy Corporation (QEC) is wholly owned by the Government of Nunavut and operates in compliance with the *Qulliq Energy Corporation Act*. QEC generates and distributes electrical energy to Nunavummiut through the operation of 25 diesel generation plants in 25 communities. The Corporation also provides mechanical, electrical, and line maintenance, as well as support services, from three regional centres.

QEC supports the Minister responsible for Qulliq Energy Corporation on regulatory and intergovernmental issues, attends to corporate objectives provided by legislation, and has the mandate to coordinate all contracting, procurement, and leasing activities to fulfil the operational requirements of the Corporation.

QEC is pleased to present its annual report on contracting, procurement and leasing activities for the 2018-2019 fiscal year.

## Procurement Objectives

QEC is committed to ensuring fair value and ethical practices in meeting its contracting, procurement, and leasing responsibilities. This is accomplished through effective policies and procedures aimed at:

- Obtaining the best value for Nunavummiut;
- Creating a fair and open environment for vendors;
- Operating with integrity and transparency;
- Maintaining current and accurate information; and
- Ensuring effective approaches to meet QEC's operational requirements.

The Corporation prepares and tables this report in the Legislative Assembly to support the integrity and transparency of its contracting, procurement, and leasing activities. With the release of this information, QEC is bound legally to safeguard competitive information which may prove harmful if disclosed to the public.

QEC strives to fully comply with the reporting requirements of its contracting, leasing, and procurement policies. The information in this report is obtained from procurement, leasing, and operational records and is deemed to be accurate and may differ from actual payment data.

## NNI Considerations

The Corporation complies with the Government of Nunavut's Nunavummi Nangminiqagtunik Ikajuuti (NNI) Implementation Act in the awarding of contracts. NNI adjustments provide an incentive to encourage Nunavut and Inuit owned businesses to respond to QEC contract proposals and tender opportunities. This report provides the distribution of contracts awarded to companies for 2018-2019 in accordance with their NNI registration identification (NNI status). The registration IDs are:

- **NTI / INUIT:** Inuit owned business registered with Nunavut Tunngavik Incorporated;
- **NNI:** Government of Nunavut registered business (not registered with NTI);
- **Local:** Locally registered company within the community in which the work is being performed (*must also be NTI and/or NNI registered to qualify as local*); or
- **Other:** None of the above.

For reporting purposes, a company that is both NTI and NNI registered is classified in the summary information of this report as NTI. A company with dual registration (NTI and Local) or triple registration (NTI, NNI, and Local) are classified as NTI. Companies without NTI or NNI status are grouped as "Other".



## Contracting, Leasing, & Procurement – Three Year Average Comparison

Contracts awarded for the purchase of capital assets and purchase orders issued for diesel fuel account for a significant portion of QEC’s annual contracting and procurement activity.

The majority of contracts issued in 2018-2019 were the result of work performed at a number of power plants and issued through QEC public tendering and RFP processes.



## Contracting, Leasing, & Procurement – NNI Status

The following chart provides the distribution of contracts awarded to companies in 2018-2019 in accordance with their NNI and NTI status. For QEC, the “Other” status primarily is for contracts for work related to the replacement of equipment and the maintenance of QEC’s power generation plants.

\*Production fuel purchased from the Petroleum Products Division (PPD) of the Government of Nunavut is technically not a status, however since it is a significant portion of QEC’s procurement activity, it warrants separate disclosure. For 2018-2019 based upon annual operational fuel requirements, approximately \$44.0M was estimated for fuel purchases from PPD, and \$7.3M was estimated to be purchased from the Uqsuq Corporation, a registered Inuit firm.

## Terminology

This listing is intended to assist the reader with definitions for QEC's technical procurement and contracting terms used in this report.

*Goods:* refer to contracts for purchased goods that are primarily entered into by QEC using a purchase order.

*Services:* refer to contracts for the purchase of services and are primarily entered into by QEC using a service agreement or service contract.

*Service Agreements:* are considered contracts for the delivery of services other than the provision of goods and construction.

*Contracts:* in the QEC context, contracts are used primarily for the purchase of capital assets (assets acquired for construction projects and large scale installations) and are awarded by invitational or public tender.

*Request for Tenders (RFT) and Public Tenders (PT):* are terms used interchangeably and refer to solicited goods or services. It is a bidding process that is open to all qualified bidders, where the sealed bids are opened in public for scrutiny and are chosen on the basis of price and quality. It also can be called a competitive tender or open tender.

*Invitational Request for Tender (IRFT) and Invitational Tenders (IT):* refer to when tender documents are sent only to contractors or suppliers specifically selected to submit tenders. For readers not familiar with GN contracting practices, please note that outside Nunavut, Invitational Tenders are generally referred to as Solicited Tenders."

*Request for Proposal (RFP):* is the process used to acquire goods or services when QEC knows what it needs as an end result, but not necessarily how best to achieve it. Therefore the Corporation seeks proposals on methods, ability, and price and can negotiate the best method to achieve the best value.

*Invitational Request for Proposal (IRFP):* are those RFPs for which proposal documents are sent only to contractors or suppliers specifically selected to submit proposals.

*Request for Quotes (RFQ):* is the process used to obtain a price for a known commodity and is used primarily for the purchase of goods and services

*Invitational RFQ (IRFQ):* are those RFQs for which quote requests are sent only to specific suppliers.

*Standing Offer Agreements (SOA):* are agreements established through a public competitive process where the supplier provides specific goods or services within an established time

frame for a defined price. QEC is also able to access all SOAs issued by and available to the GN.

*Sole Source (SS):* A sole sourced contract or purchase is one in which the corporation believes, on reasonable grounds, that one of the following is applicable:

- i. The goods, services, or construction are urgently required and delay would be injurious to the public interest; or
- ii. Only one party is available and capable of performing the contract; or
- iii. The contract is an architectural or engineering contract that will not exceed \$25,000; or
- iv. Any other type of contract that will not exceed \$5,000 in value.

## Section 1 Service Agreements

Service agreements are normally used by QEC for the procurement of services other than the provision of goods and construction. In the 2018-2019 fiscal year, 86%\* of service agreements were acquired through the tender or Request for Proposal (RFP) and Request for Quotes (RFQ) processes, as well as through Standing Offer Agreements (SOA) of the Government of Nunavut. Service agreements are used primarily for maintenance type services including sealift orders and quite often are for multiple communities or regions.

## Section 2 Contracts

Contracts are used primarily for the purchase of capital assets. These assets are acquired for project construction and large scale installations and are traditionally awarded by invitational and public tender.

The majority of contracts issued in 2018-2019 were associated with work performed at a number of power plants and the annual sealift, and issued through public tendering and RFP processes.

Major contracts were also issued for equipment replacement and installation at some of the power plants. The data presented below is for contract values at the time the contract was awarded. The award is a static value and may not reflect what was actually paid to a vendor throughout the multi-year life of a contract.

Contracts issued in 2018-2019 were significantly lower than in 2017-2018 due largely to the awarding of three contracts in 2017-2018 for the replacement of fuel lines and the refurbishment of the bulk fuel storage at the Iqaluit plant, and the award for the installation of a District Heating System at the Iqaluit Aquatic Centre, all reported in last year's report.

## Section 3 Air Charters

Air travel by QEC employees is typically provided by commercial airlines. It is the policy of QEC to only charter aircraft when more economical travel is unavailable or impractical. QEC charters aircraft to address urgent power plant repairs or to meet urgent operational requirements.

Air charters represent the lowest value group of procurement activity for QEC.

## Section 4 Purchase Orders

QEC uses purchase orders to support payment for contracts, services, supplies, equipment, and production fuel for the Corporation. Purchase orders account for a significant portion of procurement activity. The tables below summarize purchase orders valued at \$5,000 or more, including those issued for services rendered as a result of amendments to service or construction contracts. To avoid duplication of reporting, purchase orders with corresponding contract or service agreements are reported under the Service and Contract Agreements tables (see Sections 1 and 2).

Purchase orders for production fuel used in QEC's power plant operations account for approximately \$50-55M each year and are reported based upon annual fuel estimates prepared by QEC's Operations Department.

\*Power plant production fuel is purchased from the Petroleum Products Division (PPD) of the Government of Nunavut in all communities. In addition, fuel is also purchased from Uqsuq Corporation in Iqaluit. The purchase order count for fuel purchases is set at 26 in total for a given year (one for each of the 24 communities and 2 for Iqaluit).

\*\*The NNI status for fuel purchases reflect 1 purchase order for Uqsuq Corporation (an NTI registered company) and 25 purchase orders for PPD.

## Section 5 Leases

The majority of QEC's leasing activity is for the purpose of employee accommodation. As shown in the following table, 96% of all leases are classified as residential. The tight housing market in Baker Lake and Iqaluit, as well as in the regional centres, has resulted in gradual increases in housing costs and is a factor when leases are renegotiated.

The majority of leases have an annual value of less than \$50,000. The procurement of new leases and the renewal of existing leases are primarily done by sole source through QEC's Property Management Division. Property developers that have space available are regularly surveyed for unit availability and pricing to meet QEC's ever evolving housing needs. Data reflects leases in place as of March 31, 2019. Leases expiring in the current year and reported in past year reports are not included. Amounts are for lease costs only paid to the landlord or building owner and do not reflect expenses for repairs and maintenance on leased properties.
